#### Hello,

I would like to address some concerns regarding CYS's response to the smith children over the last few days. Per regulation, under Title 23 statutes 6368 and 6364, I do not believe the Dauphin County Children and Youth Services agency met or continues to meet the best practice and standards in conformity with state and federal mandates. These mandates are implemented to ensure the safety of children at risk of neglect, and suspected child abuse. The Bureau of Child Welfare Services coordinates with the Bureau of Policy and Program Development to ensure that county and private provider operations are following these mandates. Dauphin County CYS failed to identify the Smith children who continued to remain homeless for an unreasonable period of time, showed symptoms of neglect, and suspicions of child abuse.

On 10/12/2023, Cys did not present for the welfare of the smith children when they were removed in very poor condition from <u>63 n 18th street Harrisburg Pa.</u> and missing for 5 days. The following day, Cys failed to appear at the Harrisburg Emergency Room where the children were seen and documented for suspected child abuse, dehydration, and where injuries were visibly evident.

Cys first laid eyes on the smith children in the evening of 10/13/2023 after a report was submitted to Commissioner Hartwick's office more than 24 hours after the children were located (after missing for 5 days). During that time, the children failed to present to their pediatric appointment, and were tardy from school.

To complicate matters, on 10/16/2023 Dauphin County Children and Youth made a decision to withhold funds for the childrens basic needs and delayed an official placement letter by denying my request to work with an agency of my choice. The agency disputed is a licensed agency in the local area that works with both Fostercare

and kinships and could readily provide all the appropriate needs for the facilitation of the matter in question. While it may not be what the agency prefers, supporting the children should be the top priority even if extra paperwork is necessary to initiate a new contract relevant agency.

It is pertinent that this matter is investigated with urgency as the children's needs are greatly impacted by CYS's poor response and failure to protect and provide. At this time, Dauphin County Children and youth has not only failed the smith children once, but is continuing to withhold their needs by delaying a timely contract between agency and foster/kinship provider services that this caretaker has a relationship with.

Hello Detective Bath,

On 10/18/2023 after we met in person, I followed up with a child line call as we had discussed. Trying to be thorough, I filed a long report. I can type a pdf at your request.

I can provide relevant documentation from text messages, Facebook messages, WhatsApp messages, and emails to show you what had been related to me regarding the smith children and my communications with other agencies. What is your preferred method of delivery?

On 10/19/2023, I contacted Penn State Hershey operator and requested to be transferred to the security department. I spoke with Officer Ford (female). I explained a very general summary of events and inquired about the length of preservation of video footage which we need for physical documentation regarding my allegations against cys and all penn state providers that were involved with the incident on 10/17/2023. I was informed that there is typically a 30 day window before footage is unavailable but it needs to be requested through the manager by law enforcement or court order. I am urging you to obtain this footage before it is lost, deleted, and can no longer be verified. Time is of the essence. I believe we were in room 54 of the penn state emergency room. I am easily recognizable. I came into the emergency room to have the smith children evaluated (oldest was in school). I was pulling a red wagon with the three smith children, Ella Rae, Eric (Trey), and Erin Noel. I had a large yellow giant bag with extra clothing, wipes, diapers, snacks, and drinks for the kids. All hallways leading in and leading out to that room with cameras from the emergency room entrance need to be preserved. Since Penn state can be liable in this matter, obtaining this TODAY is crucial.

CYS, as legal guardians, did not arrive at the hospital when they were informed

multiple times that I needed to be back at my home by 4 to get my own children and Erica smith off the school bus. They had a 2 hour window to send someone out from cys. They did not show up. Per the circumstances and discussion with Rachel Kuhr the best and only option to protect the smith children, my children, and myself, was to request staff come in to relieve me and provide them with safe adult supervision, so I could get home for 4 children. Rachel Kuhr is a credible witness to statements made to me by penn state providers. Statements were: 1)leave with all three children, or 2) leave with no children. At no time was I a risk to these children since they were "allowing me to leave with all 3". But because I did not "conform" to the the choices they provided, I was not permitted to take any. Per my request, Rachel, selflessly remained on the phone with me for almost one hour until I was safely out of the hospital building and walking to my vehicle. I felt that my family's life was in danger and I needed a credible witness to protect my family. She is a social worker and director of foster and adoption services with Jewish Family Services in Harrisburg, Pa.

Please note, I have absolutely no obligation to the smith children. I am not their mother, not their father, and not a county agency who's duty it is to identify children at risk, endangered, neglected, and abused. All efforts made on their behalf by myself, have been selflessly and completely voluntary.

I notified cys for almost 2 hours that Eric smith (dob 6/18/2020) had been harming himself while in the penn state emergency room . Every time one of his siblings would take a toy from him, he would throw him himself back from a seated position on the floor and bang his head into the linoleum. I disputed taking Eric home without a safety plan in place, because I was 1) concerned for his safety 2) I could not assume liability knowing that he was hurting himself and that I wouldn't be able to keep him safe with 8 children on my own.

My children went through a lot of turmoil for the smith children that were

unexpectedly dropped into our family life and home from thin air because their mother lied after abandoning them for five days without clean clothes and basic necessities at 63 N 18th street, Harrisburg, Pa. We did not seek them out, this came to us.

When I walked into penn state emergency room looking for care for these poor helpless children, I was walking into a fiery bush. I knew, once I filed a complaint against cys, there was a strong chance for retaliation. I am in no means alleging a presumed "credible doctor" knowingly lied for cys. But I believe she was not provided with full facts of the smith children from cys. I believe she was not aware that mother had domestic violence charges for injuring their father in 2018. I believe she was not aware that cys was not at the scene where the children were found abandoned by mother. Without this information, she would not be able to properly assess the source of the old scars I was concerned for. But these details are facts, and all physical evidence is obtainable by law enforcement.

Yes please they are in so much danger and I've been working on this statement since yesterday and again today at 5 am. It's horrifying what happened. Their names are Erica Jean smith 12/17/2017, Ella Rae smith 6/18/2020, eric (trey) smith 6/18/2020, Erin Noel smith 6/18/2021. The worst marks are on the twins Ella and eric. Ella has horrible scars on her underside right wrist and she has what looks like cigarette burn marks on her lower back. I'm sure by now lots of the black and blue marks are faded. But those should still be there. She also had multiple bruises on the right side of her panty line. She had no bladder control and appeared to be in an utter state of shock.

Eric has a deformed head and when he cries the lip droops. I had penn state do a cat scan but Dr crow was not listening to me she was only paying attention to cys. You should have that rechecked somewhere else. Eric had numerous black and blue bruises all over his body. I'm sure most have faded but he still has a permanent scar to the back of his hair line/neck. Looks like a cut. He may still have the scratches on the back of his right shoulder. He also has a tiny pin hole above his butt crack. The children are very thin. I was feeding them non stop and pushing fluids because they were all dehydrated. If penn state was in on this I would urge you to try and get the discharge paper from upmc Harrisburg. That's where the discharge originally documented suspected child abuse on 10/13/2023. Perhaps you can pull video footage too. Ella Rae was leaning on a wall when they were trying to get her weigh. She was very lethargic. They saw Alyssa N Schatz, PA-C-NPI #1790150324. When we were there I connected Alyssa to the case worker at CYS and CYS refused to provide her information. I no longer have the paper from UPMC because it was confiscated by Penn State. I told them I need it back and they never gave it back to me.

I can finish telling you the story when we meet. I would like to meet Monday. I'm in fear of mine and my children's lives. I am sending my kids to school Monday but we need emergency protection. We came to Baltimore for the weekend to celebrate my children's birthdays and to ensure our safety over the weekend.

I tried to get a restraining order against cys and Marcie on 10/18/2023. I went down to the human services building and spoke with Kim Sourbear. We are not safe in our home. I told the following people we do not feel safe:

We don't know what to do or where to go. The schools cannot protect my children. They already tried and were unsuccessful. I have a voicemail recording from Leah Booker (director of Ugro child-care) telling me that CYS was not going to wait for the police, and Sara Lindemuth Anna Carter Primary, verbally told me that they need to discuss my request for police presence with the legal team. We have no protection from Police. Susquehanna township Police Department, Corporal Glenn, and Officer Bretz said municipal cannot go above County. We have no protection and the allegations I am making are very serious. Penn State Hershey is involved and so is Harrisburg Hospital. Harrisburg Hospital had documented the diagnosis of the Smith children as "suspected child abuse." However, i asked cys to take emergency custody and they said "no suspected child abuse was submitted". I had a copy of the discharge summary from Harrisburg ER dated 10/13/2023 but it was taken from me on 10/17/2023" at the Penn State ER and never returned. I am hoping you can still access it from UPMC but either way I have a few pictures of the scars and kids. I am afraid they will erase the footage from the penn state security cameras.

I spoke with Officer Ford and they only hold it for 30 days. Time is of the essence. Cys endangered, neglected, and violated the rights of all 4 smith children from October 12, 2023 to October 18, 2023. These children have permanent injuries. They will likely cover up and delete the pictures of the injuries but I can tell you exactly where each scar is and I still have two pictures in my phone for those kids. Eric Smith 6/18/2020, has what looks like a cut scar behind his neck right below the hairline, he had two scratches on his right shoulder/back. He had multiple black and blue marks on the from/back legs, arms, butt. His head is protruding to the side in the back. Ella Rae smith 6/18/2020 has very bad parallel line scars on the bottom of her right wrist. They look like intentional burns or cuts. They are thick. She also had 4-5 bruises on her panty line in the front right side. She was the first one that I noticed looked like a cigarette burn on her lower back. She had multiple bruises on front/back legs, arms torso, back etc. They placed the 4 children back in Marcie Wittlins care. Marcie was charged with domestic violence for causing permanent injury to the father of her kids. I


personally saw his injury on 10/18/2023. It's his fight pinky finger. I was witness to false reports at CYS when Marcie told Amanda Ozenbaugh that she can't get section 8 due to retail theft. I found out two days later from Eric Smith father that it was actually because of DV in lower Allen. CYS only removed the children from my care because I would not comply with their demands to work kinship with families united. I was adamant on working with Pa Mentor who they coerced into not working with me (text). They are also retaliating because I reported everything to Commissioner Hartwick (Julie), OCYF, and Scott Perry. The final straw was when I told them I needed Eric smith (kid) to have a safety plan at penn state for headbanging. They told me if I didn't take all 3 home, I was not allowed to leave with any smiths at the penn state emergency room on 10/17/2023. They are retaliating and going after my children for anything that they can find because of how serious their actions are. They are seeking to pin me for my sons safety bed which was ordered by his Pediatrician over a year ago to shift blame and divert attention from the heinous mistakes they made. They are trying to cover up their actions. Marcie had abandoned her kids for 5 days unclothed and soiled in fences. Only Harrisburg PD and I showed up on 10/12/2023 (this was after 6 hours of missing child reports). Cys failed to lay eyes on the children for almost 2 days despite how they were found. I had to provide clothes from my trunk since the Smith children had none. Cys and Marcie are the primary perpetrators. Penn State Hershey is a secondary perpetrator. I am not quite sure where the police stand. As of right now I have been trusting them until they prove us otherwise but I have not seen any criminal steps taken by either the Harrisburg PD or Susquehanna township PD who are both aware of the



I am a little better now that we are in Baltimore but I was vomiting all of last week and had to be prescribed promethazine (nausea).

21.On October 23, 2023, the Agency received a voicemail from Eric Smith, II, providing a new telephone number to contact him.

22. On October 23, 2023, the Agency caseworker contacted Eric Smith, II. Eric Smith, II was angry that the Agency caseworker would not share with him where Marcie Smith and the children were residing. The Agency caseworker asked Eric Smith, II to present to the Agency to provide a drug screen. Eric Smith, II stated he was homeless and free to come in anytime. The Agency caseworker asked him to present to the Agency on October 24. Eric Smith, II refused, stating that he was busy and unable to come into the Agency.

23.At this time, the Agency is requesting that the children remain with Marcie Smith under Court-Ordered Protective Supervision, so that the Agency can ensure that she is complying with all necessary mental health treatment and that she maintains stable housing for herself and the children. The Agency has concerns about Eric Smith, II's substance use and homelessness and has not yet had the opportunity to assess Eric Smith, II. Additionally, the Agency has concerns about possible domestic violence.

24. Due to concerns for substance abuse by Eric Smith, II and concerns for domestic violence, the Agency is requesting that the address for Marcie Smith and the children be withheld at this time.

25.In an effort to avoid placement, the Agency is requesting Court-Ordered Protective Supervision of the child. Additionally, the Agency facilitated a Crisis Rapid Response meeting on October 16, 2023.

26.At this time, it is not safe for ERIC SMITH, III, to remain in the care of Marcie Smith without Court involvement because of concerns for Marcie Smith's mental health and housing instability. The Agency has concerns about Smith, II's substance abuse and homelessness.

27. The subject minor child is not currently under the supervision of the Agency.

28.It is denied that ERIC SMITH, III has any Native American heritage that meets the definition under the Indian Child Welfare Act.

WHEREFORE, it is contrary to ERIC SMITH III's welfare, health, or safety and best interests to remain in his parents' care without Court involvement. At this time, Court Ordered Protective Supervision is necessary and cannot be prevented.

Hello,

I would like to bring this urgent matter to the Courts attention. I have contacted both state and federal agencies regarding the matter. Dauphin County Children and Youth is under investigation but they are covering up liability to protect their crimes. Please share this complaint with the Honorable Judge Cherry. I accidentally received a document signed by The judge scheduling a juvenile adjudication hearing on November 15, 2023 for the 4 smith children. I would like the Judge to be informed that these four children were abandoned for 6 days and were found after I made numerous calls to 911 and childline. Two of the children were unclothed and the others were soiled in feces. Dauphin County failed to respond to the crisis and then failed to assist them for 5 days. I had to contact Commissioner Hartwicks office because the children had numerous bruises. I took the four children two Harrisburg Hospital where it was documented as suspected child abuse but Dauphin County CYS is covering it up. I fostered and adopted through Dauphin County for three years and they do not want anyone to find out.

After I filed a complaint with OCYF, Dauphin county cys returned the children to the mother that abandoned them without clothes and food. I later found out that she also had a charge for domestic violence of serious bodily injury. This is similar to the story that happened in adams county. Numerous detectives are looking at this case and I have shared it with Governor Josh Shapiro, Scott Perry, and multiple other agencies and outlets.

After my complaint, CYS overturned my families life in retaliation and violated many laws. There is significant public corruption occurring and I am attaching a complaint I filed in two different courts.

I have approximately 400 pages of evidence for Judge Cherry if he would like me to share it with the court. I would like to see these children saved and Dauphin County CYS held liable for the corruption, extortion, and corruption.
